

## DISCLAIMER

I have not consumed drugs or alcohol before accessing the facility, nor will I consume drugs or alcohol during my visit to the facility and/or I am not under the influence of mind-altering substances during my visit. 4. I hereby expressly waive my right to assert any and all claims for damages, injury or consequential damage which may occur in connection with my use of the Jump Dome facility or the offered activities, unless Jump Dome should act in a deliberate or grossly negligent manner.

5. Jump Dome assumes no liability for the risks and hazards to health of the user of the facility.

6. Jump Dome assumes no liability for the loss of personal effects.

7. Jump Dome assumes no liability for damages caused by force majeure or unlikely accident.
